**1. About this document**

**1.1 Function**

This operating instructions manual provides all the information you need for the mounting, set-up and commissioning to ensure the safe operation and disassembly of the safety switchgear. The operating instructions must be available in a legible condition and a complete version in the vicinity of the device.

**1.2 Target group: authorised qualified personnel**

All operations described in this operating instructions manual must be carried out by trained specialist personnel, authorised by the plant operator only.

Please make sure that you have read and understood these operating instructions and that you know all applicable legislations regarding occupational safety and accident prevention prior to installation and putting the component into operation.

The machine builder must carefully select the harmonised standards to be complied with as well as other technical specifications for the selection, mounting and integration of the components.

### 2.2 Special versions

For special versions, which are not listed in the order code below 2.1, these specifications apply accordingly, provided that they correspond to the standard version.

### 2.3 Destination and use

The BNS 33-...-2187/-2363 safety sensor is designed for application in safety circuits and is used for monitoring the position of movable safety guards to ISO 14119 and IEC 60947-5-3. To actuate the safety sensors, only the BPS 33 actuators can be used, conventional magnets are not suitable.



The safety switchgears are classified according to ISO 14119 as type 4 switching devices.

The safety switches are used for applications, in which the hazardous situation is terminated without delay when the safety guard is opened.

Only the entire system consisting of the safety sensor (BNS 33-...-2187/-2363), the actuator (BP 33) and the safety-monitoring module (AES/AZR/SRB) meets the requirements of the standard IEC 60947-5-3.



The user must evaluate and design the safety chain in accordance with the relevant standards and the required safety level.



The entire concept of the control system, in which the safety component is integrated, must be validated to the relevant standards.

(Determined values can vary depending on the application-specific parameters  $h_{op}$ ,  $d_{op}$  and  $t_{cycle}$  as well as the load.)

If multiple safety components are wired in series, the Performance Level to ISO 13849-1 will be reduced due to the restricted error detection under certain circumstances.



### 3.4 Adjustment

The LED of the BNS 33 variants can only be used as a rough setting tool. The correct functionality of both safety channels must be checked by means of the connected safety-monitoring module.



#### Recommended Adjustment

Align the safety sensor and actuator at a distance of  $0.5 \times s_{a0}$ .

## 4. Electrical connection

### 4.1 General information for electrical connection



The electrical connection may only be carried out by authorised personnel in a de-energised condition.

The safety sensors must be wired in accordance with the wire colours or the pin configuration.

The proper functioning must always be checked by means of the connected safety-monitoring module.

### 4.2 Contact variants

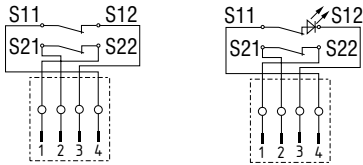
The contact position shows the actuated sensor function when the safety guard is closed. For safety sensors with LED, the LED is illuminated when the safety guard is closed.

Safety contacts: 02Z: S11-S12 and S21-S22  
12Z: S21-S22 and S31-S32  
Signalling contact: 12Z: S13-S14

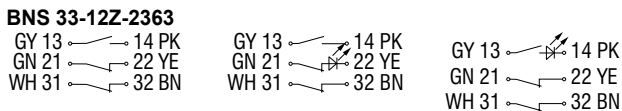

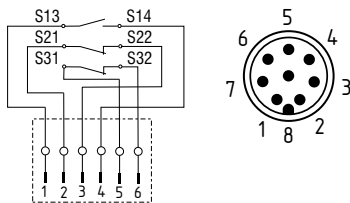

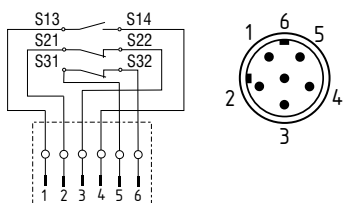

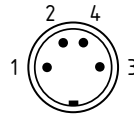
Information for the selection of suitable safety-monitoring modules can be found in the Schmersal catalogues or in the online catalogue on the Internet: [www.schmersal.net](http://www.schmersal.net).

Connecting multiple BNS 33-2ZG-2187/-2363 BNS 260-11z safety sensors to one safety-monitoring module is possible. In this configuration, all safety-relevant NC contacts are wired in series (check if authorised).

Safety sensors equipped with a LED however shall not be wired in series. If the LED's of the series-wired safety sensors are in the NC paths, the luminosity of the LED's is highly reduced and the increased voltage drop will possibly cause the voltage dropping below the minimum input voltage of the downstream safety-monitoring module.

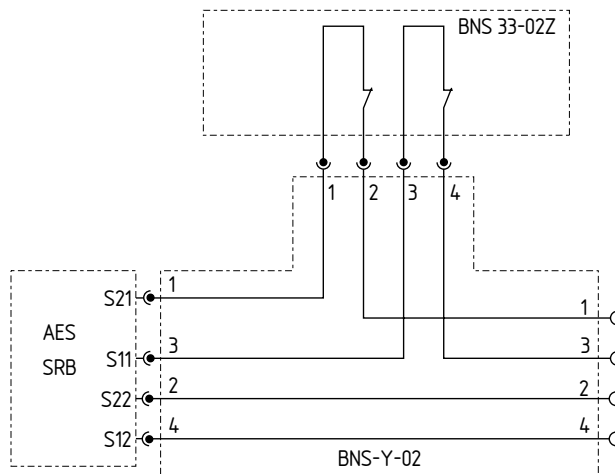
#### Integrated connector M8, 4-pole

## 5. Set-up and maintenance

### 5.1 Functional testing

The safety function of the safety components must be tested. The following conditions must be previously checked and met:

1. Fitting of the sensor and the actuator
2. Fitting and integrity of the power cable
3. The system is free of dirt and soiling (in particular metal chips)

### 5.2 Maintenance

In the case of correct installation and adequate use, the safety sensor features maintenance-free functionality. A regular visual inspection and functional test, including the following steps, is recommended:

- Check the fitting of the sensor and the actuator
- Remove possible metal chips
- Check the cable for damage.



Adequate measures must be taken to ensure protection against tampering either to prevent tampering of the safety guard, for instance by means of replacement actuators.

**Damaged or defective components must be replaced.**

## 6. Disassembly and disposal


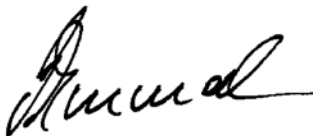
### 6.1 Disassembly

The safety switchgear must be disassembled in a de-energised condition only.

### 6.2 Disposal

The safety switchgear must be disposed of in an appropriate manner in accordance with the national prescriptions and legislations.
